## Mimecast secures \$62 million PE investment

Mimecast, the fast growing cloud-based email management, archiving and security company, has secured \$62.15 million in Series C funding led by the private equity firm Insight Venture Partners, with existing investors Dawn Capital also participating.

Mimecast, which was only founded in 2003 but is already in use in 70% of the UK's Top 100 firms, plans to use the funding to accelerate the development and deployment of new technology and to support plans for rapid expansion into the US market. Co-founder CEO Peter Bauer commented "We believe email needs to be rewired if it is to continue to deliver real value to businesses. Building on our history of innovation, we are working to make email more collaborative and more interactive to realize the true value of the vast amount of unstructured data in email stores."

- Mimecast has beefed up its archiving offerings with support for Microsoft Sharepoint and Outlook v4, plus a new file archiving product supporting services such as Dropbox, network shares and home drives. Mimecast say the Mimecast File Archive system will create an archiving solution for multiple repositories with a single point of ediscovery and management that supports regulatory ➡

➡ compliance needs. Mimecast now also has an iPad app (Mimefiles, available from the AppStore) that provides users with a unified view of all their files and emails, along with a full audit trail.

## UBIC files for NASDAQ IPO

UBIC Inc, a provider of Asian language ediscovery products and services, has filed with the US SEC for a proposed initial public offering on the NASDAQ market. The stock issue and price has still to be set.

## Who's in and who's out ? November's wins, deals, swapouts and rollouts

**kCura** has announced a trio of law firm wins for its Relativity ediscovery software platform. National law firm **Kasowitz Benson Torres & Friedman LLP** will be using Relativity in complex commercial litigation work. Minneapolis law firm **Nilan Johnson Lewis PA** will be using Relativity firmwide for assisted review and text analytics. And international firm **Morgan Lewis & Bockius LLP** will use Relativity to expand the inhouse technology portfolio available to its eData ediscovery practice group.

Austin, Texas-based litigation lawyers **Mueller Law** has implemented LawBase case and matter management software from **Synaptec Software** to track its product liability, surgical mesh, medical malpractice, birth injury and class action litigation cases. The implementation includes a bi-directional Outlook/Exchange interface and iManage document management system integration.

**Clyde Snow** of Salt Lake City, a long-time user of **Orion Law Management Systems** software, has installed Orion's marketing management system, along with Microsoft Exchange Synchronization for Outlook email, to streamline communications and marketing activities.

## Duff Phelps buys iEnvision

The acquisitions and consolidation continues in the legal IT world with financial advisory and investment banking firm Duff & Phelps Corporation (NYSE: DUF) buying information lifecycle management specialists iEnvision Technology. The transaction adds 24 staff to Duff & Phelps' Dispute & Legal Management Consulting team, including iEnvision founder and president Matthew Hobbs who joins as a managing director. Duff & Phelps say the acquisition further strengthens the consultancy's services in the areas of corporate and government legal department strategy, technology implementation, compliance and risk management.

**CASE EVALUATOR GOES MOBILE** Thomson Reuters has introduced a mobile version of the WestlawNext Case Evaluator reporting tool for evaluating negotiation and settlement strategies, and analyzing verdict trends in specific jurisdictions. The system is only available on small format devices such as the iPhone and Android smartphones.

**AMICUS IN THE CLOUD** Gavel & Gown Software has released the Amicus Attorney Cloud Edition, a web-based version of its well known practice management system. Gavel & Gown president Ron Collins says Amicus Cloud will enable lawyers to carry out full practice management on any web browser, whether on a desktop PC or iPad, with full integration with email, calendaring and contacts.

LexisNexis has entered into separate agreements with Bellefield Systems and the Frayman Group to expand the capabilities of its Juris Suite of law firm billing, accounts and financial management software. Bellefield is adding a mobile time entry solution for iPad, iPhone and 'Droid Juris users via its iTimeKeep system, while Frayman is adding a client intake compliance (including conflicts of interest checking) module.
